GiC Gender Representation in Administrative Tribunals



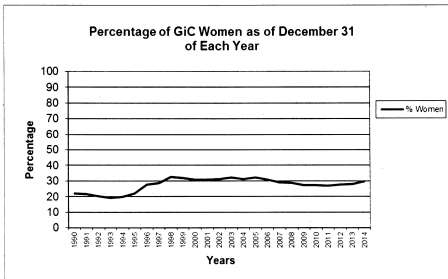
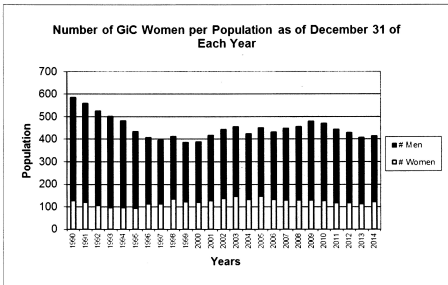

GiC Gender Representation in Agencies



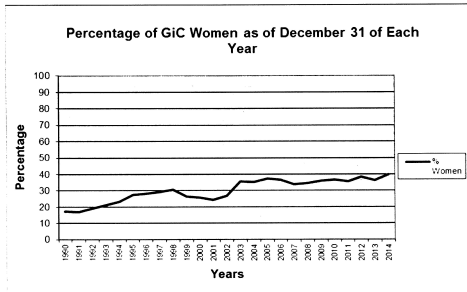
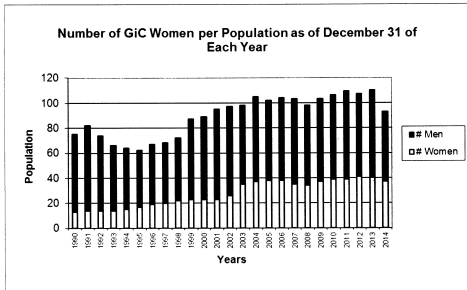
