## MEMORANDUM TO THE MINISTER

### ANALYSIS OF CITIZENSHIP TEST QUESTIONS

#### FOR APPROVAL

#### SUMMARY

- Citizenship and Immigration Canada (CIC) regularly monitors the performance of the written citizenship test in order to track pass rates, and to identify problematic questions or other issues that could affect the outcomes for applicants who take the test.

- 

- During the second week of June 2012, CIC met with citizenship judges to discuss the oral versions of the questions

CIC is working with the Citizenship Commission on modifications to oral questions to improve their clarity and fairness, while still keeping them in line with the corresponding written test questions.

- In response to a previous memorandum to you (see memo F-7670 at Annex E),

**BACKGROUND:**

- *Discover Canada* and the accompanying citizenship test are designed to ensure that new Canadians have an in-depth understanding of Canada to further their integration in Canadian society.
- To ensure the integrity of the citizenship test, CIC periodically re-scrambles the test versions.
- CIC undertook a limited monitoring of the written test results to assess the performance of the questions. The monitoring exercise for the written tests took place

To address this decrease in the pass rate, we have been reviewing the formulation of questions.

- While CIC collects data on the written tests in a systematic manner, no statistics are available for the oral versions of the test. As such, the assessment of the performance of the oral knowledge test and of the adequacy of oral test questions relies on anecdotal information from the Citizenship Commission.

**CURRENT STATUS**

- From the test results in the monitoring sample, we reviewed questions with a pass rate below 75%.
- In reviewing these questions, the following elements were considered:
  - question pass rate (with particular attention paid to those questions with a pass rate below 60%);
  - reference to the correct answer in the guide (i.e.
  - complexity of language used and the assigned level of difficulty of the question.

- A detailed table of our analysis and recommendations is attached (see Annex A).
  
- As needed, CIC works with the Citizenship Commission on oral questions. In June 2012, citizenship judges provided CIC with comments on the performance of the oral citizenship test questions. Oral versions of test questions are based on the approved written versions. An example of an oral version of the knowledge test, with a written test version for comparison is attached (see Annex B).
  
- CIC has been reviewing comments submitted by citizenship judges regarding the performance of oral questions. While there is some overlap of poorly performing questions in both the written and oral versions of the test, judges have identified other oral questions that could benefit from a minor re-formulation. CIC continues to work with the Citizenship Commission on modifications to the oral test questions.

- As needed, responsive messaging will be prepared to address the lower pass rate  
 Messaging will continue to reflect information gleaned through our monitoring activities, in such a way as to not compromise the integrity of the test.

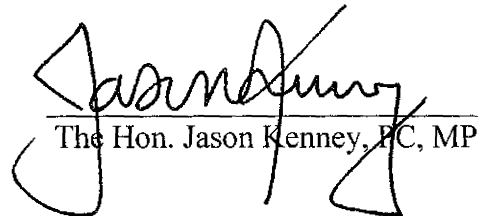
