PROPOSED RESPONSE:

- Diversity is one of Canada's greatest strengths the contributions of Canadians and newcomers of all religions, ethnicities and cultures have made Canada the country that it is today.
- Canada recognizes the potential of all Canadians, and helps to foster their social, cultural, and economic integration into Canadian society.
- The Multiculturalism Program has new policy objectives which seek to build an integrated, sociallycohesive society, to better assist public institutions to be responsive to our diverse population, and to actively engage in discussions on diversity at the international level.
- The Program uses a number of instruments to implement its objectives, including grants and contributions, public education initiatives, partnerships with other levels of government and public institutions, and engaging national and international organizations on issues related to diversity and integration.

BACKGROUND:

- The Multiculturalism Program derives its mandate from the Canadian Multiculturalism Act of 1988, which embeds and reaffirms the 1971 Multiculturalism Policy of Canada.
- The Multiculturalism Policy and the Canadian Multiculturalism Act have proven flexible enough to accommodate policy and program changes over time. However, Canadian society has become more diverse since the 1970s, largely due to shifts in immigration patterns.
- The 2006 Census revealed that Canada is home to people from over 200 ethnic origins, with visible minorities accounting for 16.2% of Canada's total population, up from 11.2% in 1996. Religious diversity has also increased, from 1.5% of Canadians adhering to non-Christian faiths in 1981 to an estimated 7.5% in 2006.
- As a result, Canada is facing challenges and opportunities related to maintaining a well-integrated diverse society as the country undergoes significant growth in cultural and religious diversity.
- In order to respond to these challenges, in 2009 the Department of Citizenship and Immigration Canada was granted the authority to implement new policy objectives for the Multiculturalism Program. The new objectives are to:
 - build an integrated, socially-cohesive society by fostering intercultural understanding, citizenship, civic memory and pride, respect for core democratic values, and by promoting equality of opportunity;
 - o improve institutional responsiveness to the needs of a diverse population; and
 - o actively engage in discussion on multiculturalism and diversity at the international level.
- The Multiculturalism Program has various tools which help to support these objectives.
- One tool is grants and contributions. Inter-Action, the new Multiculturalism Grants and Contributions Program has a budget of \$10.9M per year and two streams: Projects and Events. The Projects stream provides funding for long term, multi-year projects that support integration. In response to a recent Call for Proposal for the Projects stream, 751 applications for funding were received. The Events stream provides funding for community events that foster intercultural understanding, civic memory and pride, and respect for core democratic values. To date, since the launch of the Events Stream, more than 180 applications have been received and 25 community events have received \$261,167 of funding.

- In addition, the Historical Recognition Program provides funding for initiatives to recognize the impact on affected communities of historical war-time measures such as internment, and restrictive immigration measures such as the imposition of the Chinese Head Tax.
- The Community Historical Recognition Program has a grants and contributions budget of \$25 million over the four- year life of the Program. In addition, \$5 million is available under the National Historical Recognition Program to fund projects with federal institutions. Both programs will sunset at the end of the 2011-2012 fiscal year.
- Public education programs such as the Mathieu da Costa Challenge, March 21 Racism. Stop It! National Video Campaign, Black History Month, Asian Heritage Month, and the Paul Yuzyk Award also support the Multiculturalism Program's objectives.
- The Multiculturalism Program also has partnerships with other levels of government through the Federal-Provincial-Territorial Multiculturalism Network. It also promotes Canada's approach to diversity, racism, anti-Semitism, and other forms of discrimination by engaging national and international organizations such as the Canadian Race Relations Foundation (CRRF), the United Nations, the Organization for Security and Co-operation in Europe (OSCE), and Task force for International Cooperation on Holocaust Education, Remembrance, and Research (ITF).
