
SUMMARY:

- The test pass rate was 85% in January, which is a slight increase (1.9%) from the December pass rate. The overall pass rate is 82.4% (from November 2010 to January 2012).
- Trends by key demographic characteristics and region remain consistent with previous months.
- Since the new scrambled test versions were introduced in pass rates by version have shifted. Version is now the lowest and the variance decreased from 11.8% from April 2011 to October 2011, to 4.8% from December 2011 to January 2012.

A test results monitoring exercise undertaken in early 2010 with Statistics Canada concluded that, in most cases, the education level of applicants explained pass rates differences.

Overall Pass Rates by Month (2010-2012):




Due to regulatory changes, as of October 14th 2010, mandatory questions were removed from the citizenship test. This change affected test pass rates by raising them by approximately 10%. In addition, retesting was eliminated on February 28th 2011. test questions were scrambled as part of the Citizenship Action Plan (CAP) initiatives to maintain test integrity and mitigate test memorization. 

Test Pass Rates by Country of Birth - Top 10 Source Countries (Nov. 2010 – Jan. 2012):







Overall Pass Rates by Month (2010-2012):






Test Pass Rates by Country of Birth - Top 10 Source Countries (Nov. 2010 - Feb. 2012):




SUMMARY:

- The test pass rate was 83.2% in which is a slight decrease (0.7%) from the pass rate. The overall pass rate is 82.5%
- New test questions were implemented on resulting in a move to versions from Therefore, test pass rates by version in Section 2 of this report were calculated using data from in order to keep reporting consistently on the versions and to avoid confusion.
- The impact of the new questions on test pass rates will be noticeable in the report. The test pass rate for the next few months is expected to drop with the introduction of new questions. However, it will likely rise again as applicants adjust to the new tests and any problematic questions are addressed.





Test Pass Rates by Country of Birth - Top 10 Source Countries (Nov. 2010 – Mar. 2012):




